E.C. was informed about the prior intimation sent by EC Member Dr. M. K. Pant (Haldwani) for not attending the meeting due to official work.

The Meeting was called to order by the President, Dr. Daisy Sahni.

- Min 1/15: The members were informed about the sad demise of the following anatomists: (i) Dr. R. N. Bajpai (Kanpur), (ii) Dr. M.N. Mahendrakar (Navi Mumbai), (iii) Dr. R.K.Jain (Bhopal), (iv) Dr.B.S Pandey (Lucknow), (v) Dr. Tripta Sharma (Jalandhar), (vi) Dr. G. Sadashivam (Hyderabad), (vii) Dr. L. Patnaik (Bhubaneshwar)& (viii) Dr. Barun Kumar Bandopadhyay (Kolkatta). Members stood in silence for two minutes to pray to Almighty God to grant peace to the departed souls and to provide strength to the members of bereaved families to bear this irreparable loss, The General Secretary was requested to send condolence messages to the members of the bereaved families.
- Min 2/15: The minutes of the last Executive Committee Meeting held on 17th November,.2014 during 62nd Annual Conference of the ASI held at Regional Institute of Medical Sciences, Imphal were confirmed and approved with the modification in the Published paper award list "To retract the name of the author Dr. Swetasmita Mishra from Dr H. J. Mehta Memorial award 2013 & Dr. Lata N. Mehta Memorial Award 2013 for not being a member of ASI and to approve the names of Dr. Kusum R. Gandhi of Loni for Dr H. J. Mehta Memorial award 2013 and Dr. Maitreyee Nandi (Kar) of Sushruta Nagar, for Dr. Lata N. Mehta Memorial Award 2013 being next in merit list for the said awards and fulfilling all the eligibility criteria". Dr. G. P. Pal suggested that Dr. Swetasmita Mishra be informed in writing about the retraction of her name from the award already announced and circulated.
- **Min 3/15:** Henceforth, every year the Secretary's report which is presented during the inaugural function is to be approved and adopted by the General Body and the same is to be sent to the Registrar of Society, office at Lucknow alongwith other papers which are submitted every year. The Annual Report of ASI presented by the General Secretary in the inaugural function held on 18th November 2014 at Imphal was approved.
- **Min 4/15:** The names of 183 new Life Members and 188 new Ordinary Members were approved for 2015.
- Min 5/15: EC members congratulated and highly appreciated Dr. Ashok Sahai and Mr. Vinay Sharma for their efforts in redesigning the ASI website. It was decided to approve the expenditure of Rs. 60,000=00 (Rs. Sixty thousand only) incurred on redesigning of the website and annual maintenance fee of Rs.4000=00 (Rs. Four thousand only) as informed by Dr. A.K. Srivastava (Treasurer). The website will be updated from time to time by Dr. Archana Rani, Assistant Professor of Anatomy, King George's Medical University UP, Lucknow

 The EC was also informed that the Registration of the ASI has been renewed with the Registrar of Societies at Lucknow for a further period of five (5) years (2015 to 2020). Dr. R. K. Verma, Assistant Professor of Anatomy, King George's Medical University UP, Lucknow is looking after this work.
- **Min 6/15:** Recommendations of the **Editorial Board Meeting** held on 20th November 2015 were presented by the Editor as given below:
 - a) All Section Editors and Editorial Board members should positively send their updated profile along with email ID to the Editor-in-Chief within a month after the conference, failing which their name may be dropped as per requirement of SCOPE (England & Wales).
 - b) Editor-in-Chief proposed concessions in publication charges:- (i) Processing fee from Rs.500/- to Rs.400/- (ii) Charges for coloured photograph from Rs.1000/- to Rs.750/-,(iii) Charges for black & white photograph, illustrations and tables from

- Rs.500/- to Rs. 400/- (iv) Maximum capping of publication charges from Rs.10000/- to Rs.7500/- while minimum charges will remain the same, i. e., Rs.2500/-.
- c) The Organising Secretary has to send the proceedings of the conference to the Editor-in-Chief within one month of the conference failing which he / she has to pay an amount of Rs.10000/- as inflation charges.
- d) All the Editorial Board members are requested to send names of three or more proactive and sincere academicians for inclusion in the panel of reviewers who can also be from the allied subjects.
- e) The audited income and expenditure account of Rs. 337,024=00 for the period 1.4.2014 to 31.3.2015 was presented and approved.
- f) Since the term of present agreement with Reeds Elsevier India Pvt. Ltd. is going to expire on 31 December 2015, a new draft agreement was presented for the next three years (2016 to 2018). It was decided to constitute a sub-committee of three persons comprising of (i) Dr. Daisy Sahni President,(ii) Dr. G. S. Longia Gen. Secretary, (iii) Dr. A. K. Srivastava—Treasurer, (iv) Dr. Vishram Singh—Editor-in-Chief (v) Dr. S. D. Joshi & (vi) Dr. Ashok Sahai.
 - The members of the sub-committee were requested to go through the draft agreement and send their comments/suggestions within 15 days to the Editor-in-Chief for onward necessary action.
- g) The Editor-in-Chief informed that five (5) issues of JASI (2 print, 2 online and 1 abstract issue) are being regularly printed.
- h) A budget of Rs. 15 Lac was approved for the year 2016.
- i) It was decided that the award winning papers will be charged 50% of publication charges.
- j) It was decided that as a safeguard measure there will be a mention that this paper was given a particular award (name of the award to be mentioned) on the title page of the paper in the Journal of ASI so that the same paper is not considered for any award in the category of published paper.
- k) The Editor-in-Chief was requested to explore the possibility of a third print issue on account of good financial health. This will further improve circulation and efforts to get the journal Indexed by more agencies of repute.

All the above recommendations were approved by the Executive Committee.
