Dear Member,

As resolved in General Body of ASI held on 30th November,2016, vide G.B.Min no.11/16(d)(ii) dated 22nd January, 2017, **No Election Notice will be sent by post by the Returning Officer.** However, it will be uploaded on Website of ASI (www.asiindia.in) in link: Election of ASI, sublink : Election Notice, by 15th July.2018.

As per the Clause 13 of the constitution of A.S.I. the elections are to be held for the following posts of Office Bearers and Executive Committee member of the Society for the term commencing from 1st January, 2019.

ELGIBILITY OF CANDIDATE:

For details kindly refer to Constitution & Rules of A.S.I. (Pages 8)

- (i) Must be a Life member or a valid regular ordinary member of the Society.
- (ii) Period of membership:
 - (a) President: Must be a continuous valid member of the society for a minimum period of 10 years.
 - (b) Vice - President: Must be a continuous valid member of society for a minimum period of 10 years.
 - (c) General Secretary: Must be a continuous valid member of society for a minimum period of 10 years.
 - (d) Editor in Chief: Must be a continuous valid member of the society for a minimum period of 10 years.
 - (e) Executive Committee: Must be a continuous valid member of society for a minimum period of 5 years.

NOTE: Ordinarily not more than one person shall be eligible for the post of executive committee from one Institution.

- (iii) **Number of conferences attended and other condition (Approved by E.C. & G.B. 11/13 (v) dated 5.2.2014 and further amended vide GB Mjn. 11/16 © dated 22nd January, 2017.**
 - (a) **President:** Minimum of 7 National conferences of the society and 2 E.C. meetings.
 - (b) **Vice - President:** Minimum of 5 National conferences of the society and 3 E.C. meetings.
 - (c) **General Secretary:** Minimum of 7 National conferences of the society & 5 E.C. meetings.
 - (d) **Editor in - Chief:** Minimum of 7 National conferences of the society, 5 E.C. meetings and 5 research papers published in indexed journal.

- (e) **Executive Committee:** Minimum of 4 National conferences of the society.

NOMINATION:

Nomination form is uploaded on ASI website; thus it will not be sent by post.

Instructions for submission of nomination form:


- (1) Nomination form correctly filled, complete in all respect, must be returned to the Returning Officer, so as to reach on or before **25th August, 2018**
- (2) Every candidate for election of various post should attach self-attested photocopy of certificate of attendance of Conference and EC meeting as required for that post along with duly filled nomination form should post to my mention residential address.
- (3) Delay in transit or lacuna on part of Postal department or Courier will not be given any consideration.
- (4) Last date for withdrawal of nomination is **30th August, 2018.**
- (5) **Candidate who will contest for election for above any post (except EC member) should give undertaking for EC meeting attendance requirement. If any information found to be incorrect any time nomination/election can be canceled at any time and candidate shall be responsible for the same.**

Eligibility to Vote:

- (1) No regular member will have the right to vote unless he /she has been a valid member of the society on 15th August, 2018. Those regular members who will pay their annual subscription after 15th August, 2018 will not have the privilege of voting.
- (2) The newly enrolled members must be a valid members of the society for at least 6 months by the 1st September, 2018 before they can exercise their right to vote.
