- a)** Regarding various activities and proposals of International Federation of Association of Anatomist (IFAA) Dr Surjit Ghatak & Dr Ashish kumar were nominated to represent ASI in General Assembly of IFAA at London held in August 2019.
- b)** The Gen. Secretary requested Dr S. Ghatak to apprise about all related activities of IFAA during the conference in London. Dr Ghatak informed to house about various activities, and proposals received from IFAA for approval by ASI.

- 1) There is proposal for giving 4 votes to large association whose members are more than 500
- 2) The Executive Committee of the IFAA recommends upgrading the research committee to rename it as a research programme. Thus, FICAR would become FIPAR.
- 3) Change in the IFAA Constitution regarding the terms of office of Vice-Presidents and the role following indisposition of the IFAA President
- 4) Proposal for the establishment of a College of Representatives within the IFAA.

G.B. discussed the proposals and approved.

- c. Dr Surjit Ghatak also told that R. Shane Tubbs Chair, FIPAT informed during the meeting that a draft of the **second edition of Terminologia Anatomica (TA2)** is now available online for your approval of all the member Associations of IFAA. (Please find this document at the bottom of the FIPAT homepage (<https://www.ifaa.net/committees/anatomical-terminology-fipat/>) we have to send our decision for approval by 15th January 2020, for final publication of document). **This was approved**
- d. As per Mint.20/18 of EC & 10/18 of GB It was propose that Dr Surjit Ghatak should chair **standing committee of 3 members to interact with IFFA** regarding contribution of ASI in news letter of IFAA (PLEXUS) & take care of IFAA related matters, other members will be Dr. Vishram Singh & Dr Dushyant Agarwal **This was approved**
- (xv) Most of the State/Zonal Chapters are functioning well, but report of activities has been received only from 2 Chapters:
- (i) 3rd Annual Conference of Kerla chapter of ASI was held on 12th January 2019 at Believer's church Medical college Hospital, and Theme of CME was 'Neurofiesta2019'.
 - (ii) The 27th Annual conference of the U. P. chapter of Anatomical Society of India was organized by S. N. Medical College, Agra on 21st and 22nd September 2019. Approximately 170 delegates participated in the conference.
 - (iii) It was suggested that members of the State Chapter shall be valid members of the ASI which **was approved** provided they were not defaulters in any way and were not suspended from the membership of ASI.
 - (iv) Intimation received from Dr Usha Chabra, General secretary NCAS that North states chapter of ASI has been dissolved and a new independent society by the name of North Chapter of Anatomist Society (NCAS) has been formed with new registration number and PAN number, which has no affiliation with the parent body i.e. Anatomical Society of India.
All were discussed and approved.
- (xvi) The venue of 68th Annual conference of ASI, 2020 was approved as SDM Medical College, Dharwad. Proposal of KMC Manglore is kept pending due to technical reasons. **This was approved by GB**
- (xvii) The following proposals received from members **were discussed and approved.**
- (i) Proposal of **Dr. C.S. Ramesh Babu** (Muzaffarnagar) duly seconded by Dr. S. L. Jethani (Dehradun) (1) regarding inclusion of Returning officer as the office bearers of ASI.
(2) constituting a committee of 3 persons to fram powers and duties of Returning officer which include Dr T. C Singel (Vice President) as chairperson and Dr P K Verma & Dr. C.S. Ramesh Babu as other members who will submit report to the Gen. secretary, at earliest. **Both were approved.**
 - (ii) Proposal of **Dr. S. L. Jethani** (Dehradun) duly seconded by Dr. Jitendra Patel (Ahmedabad) about suggestions for following amendments in the constitution, Rules and Regulations of ASI.
 1. Legal Jurisdiction of Society shall be at Lucknow, which is Permanent office of society (in the memorandum of Association). The same should be included at appropriate place in the constitution, Rules and regulations. **It was approved.**
 2. Point 6 (Page 4) - Orgnizing secretary/ chairman of the conference shall be nominated as next president of society and his/her name should be approved by executive Committee. **It was not approved.**
 3. There is proposal that Secretary/ President of State Chapters shall be invited members of the executive committee. **It was approved.**

4. Point 5 (Page 6) - Privileges of members point 1 & 7 which are related to Railway concession and society journal shall be deleted/amended as now we are providing on line free journal. **It was approved.**
5. Point iii (Page 7) – In the duties of General secretary - It should be added that general secretary will publish the minutes of the meetings (including Executive and General Body meetings) on website. **It was approved.**
6. Point 13 (Page 9) Elections if required shall be held through the electronic mode (Through website). **It was approved.**
7. Page 13 (last paragraph) – If last date to receive nomination i.e. 25th August falls on Sunday or Holiday then next working day will be the last date to receive nomination. **It was approved.**
8. Authors of award papers who receive award shall submit the awarded paper for publication in society journal in the proper format of publication of paper. For publication of awarded paper editor should not charge any fee to-words publication of paper in journal. **It was approved.**
9. If any Executive Committee Member does not attend the EC Meeting without information, forfeits right of contesting election for 4 years for any post shall be modify to two years. Further, and E C Member, one who continuously elected and not attending the meeting more than two times can be prevented from contesting for any post for next two years.

It was not approved by GB

- (iii) For amendments in Guidelines for Organizing conference received after meeting of Dr. Vishram Singh, Dr. T C Singel & Dr. S L Jethani & following points were discussed-
- a. The NATCON preferably to be held zone - wise viz. North, South, East, West and Central,(states distribution will be same as given in fellowship programme). **It was approved.**
 - b. The dates of conference should be in the month of November or December and to be decided in consultation with the Gen. Secretary. **It was approved.**
 - c. Before final approval of place of conference, The mode of organization to be inspected by Gen. Secretary/ his representative, Vice President and a member of executive committee in the month of Feb/march who should talk to the department members and principle of concern college and visit available facilities to hold the conference. Committee will submit feasibility report to the Gen. secretary, and on the basis of feasibility report Gen. secretary should issue letter to the Concern College and department for organization of conference, and up-lode the information on website. This process shall be completed in all means latest by the end of March, every year. **It was not approved.**
 - d. The standard protocol for seating arrangement at inauguration ceremony of conference to be followed as under, Starting from the right to left – Joint Organizing Secretary, President of ASI, Chief Guest, Guest of Honour (if any or Dean/Principal), Gen. Secretary of ASI and Organizing Secretary. **It was approved.**
 - e. Conference website should be uploaded by the Organizing Secretary only after consultation with the Gen. Secretary. **It was approved.**
 - f. Members who wish to organize the conference may present facilities (Both organizational and accommodation) available with them, in a power point presentation in the EC before a final go ahead is granted. if executive committee is satisfied by the presentation clause “c” will not apply. **It was approved**
 - g. One who applies to organise the conference (NATCON of ASI) the Concern HOD or his/her representative shall be called for attending the Executive Committee meeting by Gen. Secretary of ASI as a invited member. **It was approved**
 - h. The Organising Secretary shall be given Rupees one lakh towards organization of conference & at the end Organizing Secretary will submit the audited detail of income and expenditure to the Treasurer of ASI. GB was informed that a **committee has been formed** to discuss this issue and submit its recommendations to Gen. Secretary Vide **Min.2-GB/19(ii)**.

- (iv) Proposal of Dr Ashok Sahai seconded by Dr S L Jethani that during the various scientific sessions chairman should be amongst the senior members of society so proper and healthy discussions can be held during presentation. It was **approved** with a suggestion that same person should not be chairperson in other sessions.

Min. 4-GB/19: Other matters


- i. It was suggested that the Dean of the concern college, during endorsement of letter to organize the conference, should also suggest the name of organizing secretary from the Anatomy department.

Resume of 67th National conference of ASI held at Vardhaman Mahavir Medical College & Safdarjung Hospital, New Delhi

The 67th National Conference of the Anatomical Society of India was organized by department of Anatomy, Vardhaman Mahavir Medical Collage and Safdarjung Hospital New Delhi at Dr. Ambedkar International Centre, Janpath Road New Delhi. NATCON began on 17th November 2019 with **pre-conference CME / Workshop** on Body, Organ and Tissue donation, focused on the need for body donation for teaching and research in various medical colleges. Pre conference workshop was inaugurated by Hon'ble Ms. Meenakshi Lekhi Member of Parliament, India.
