As resolved in the General Body of ASI held on 30th November, 2016, vide GB.Min.no.11/16(d)(ii) dated 22nd. January, 2017, **No election notice will be sent by post by the Returning Officer.** It will be uploaded in the website of ASI (www.asiindia.in) under the link: Election of ASI, sublink: Election Notice, by 15th July, 2022.

As per the Clause 13 of the Constitution of ASI the elections are to be held for the following posts of Office Bearers and Executive Committee Members of the society for the term commencing from 1st January, 2023.

ELIGIBILITY OF CANDIDATE:

- (i) Must be a Life Member or a valid regular ordinary member of the Society
- (ii) Period of Membership & Number of Conferences attended and other conditions: Please refer to the Rules & Regulations for Elections provided in the website of ASI under the heading about ASI sub head constitution page no. 9.

NOTE: Ordinarily not more than one person from one department/institute shall be eligible for the post of executive committee member.

NOMINATION PROCEDURE:

Nomination form is already uploaded on ASI website along with this notification and members desirous to contest election can download the Nomination Form from the website. **Nomination form will not be sent by post.**

INSTRUCTIONS FOR SUBMISSION OF NOMINATION FORM:

- (1) Correctly filled nomination form complete in all respects must be sent preferably by registered post to the Returning Officer at the address given above so as to reach him on or before 25th. August, 2022.
- (2) Members contesting for the various posts should attach self-attested photocopies of certificates of attendance of the conferences and EC Meeting as required for that post along with the duly filled nomination form by post to the Returning Officer at the address given above.

- (3) Returning Officer shall not be held responsible for any postal delay.
- (4) **Last date for withdrawal of nomination is 30th August 2022.**
- (5) **Members contesting for the posts other than EC members shall give an undertaking for the EC Meeting attendance requirement.**
- (6) Nomination forms with incomplete information and /or incorrect information shall be liable to be rejected and the onus for the same rests on the contestant.
- (7) If need be, election shall be held by **online mode. Window for voting shall be opened for members whose name appears in valid life members till 15th July 2022.**
- (8) **Window for voting shall be open between 3rd to 8th Oct.2022.**
- (9) **Results will be declared on 12th Oct.2022 at ASI Website.**
