The meeting was called to order by the President Dr. Bijendra singh.

- Secretory expressed about sad demise of some members during Covid-19 Pandemic names of which are **Obituary:** not known at present. Members stood in silence for two minutes to pray to the Almighty God to grant peace to the departed soul and provide strength to the members of bereaved family to bear this irreparable loss. The General Secretary requested all members to provide names of departed souls.
- Min. 1-GB/22 : The members acknowledged the receipt of the minutes of the last General Body meeting held on 20th November, 2019 in the Auditorium of Dr. Ambedkar International Center, Janpath Road, New Delhi, during 67th Annual Conference of ASI. Circulated among members members vide No ASI/ Secy/19-min/GB/02 Dated 04.12.2019 by uploading in the ASI website www.asiindia.in Link-Meetings were confirmed and approved.

Min.2-GB/22: (i) Matter arising from last GB meeting: Min :

A.-Recommendations of committee about power & duties of Returning officer vide GB minutes 3-GB-19 (xvii)-(i)(2) committee of 3 persons to frame powers and duties of Returning officer which include Dr.T. C Singel (Vice President) as chairperson and Dr P K Verma & Dr. C.S. Ramesh Babu as other members who will submit report to the Gen. secretary. Recommendations of the committee was put before the house which are as follow:-

1. <u>Nomination</u> – Returning officer (R.O.) of society shall be nominated amongst the senior life members of society by the Executive committee (E.C.) & subsequently approved by General body (G.B.).During nomination of Returning officer it shall be ensured that R.O.cannot contest for the other official post of society & for E.C. member.

2. **Tenure**- Normally tenure of R.O. will be for 3 years. His/ Her tenure can be extended for one more term by the E.C. and G.B.He/ she can be removed from the post be General body on the recommendation of EC in case of gross negligence.

3.Duties- 1.Returning officer shall be responsible for smooth conduction of election of office bearers of society & of executive committee members as per rules & regulations of society. He/ She should give wider publicity amongst the members of society for conduct of elections by using electronic (email) & social media.

2. R.O. is empowered to notify the election process, invite nominations, conduct of elections if required & declaration of results.

- 3. R.O. is empowered to reject the nomination for not fulfilling the prescribed eligibility criteria &/or nomination received late.
- 4. R.O. can demand suitable budget for conduct of elections if required & details of expenditure shall be submitted to treasurer immediately after end of election process.
- 5. After declaration of results R.O. shall place detailed report of complete process in executive committee and submit copy of that to general secretory of society for record.
- 6. All the decisions of R.O. shall be final & cannot be challenged at any level.
- 7. Previlages: Being an office bearer of society, RO shall get privilege of free accommodation while attending national conference to be arranged by organizing secretory. He/ She enjoy any other privileges given to other office bearers of the society.
- Post of RO included in the constitution as office bearer.
 All above was discussed & approved by GB. GB also approved name of Dr T C Singhal as recommended by EC

B- Recommendation of committee vide EC minutes 4-EC/19 & GB minutes 2- GB-19 (ii) about the suggestion of Dr S L Jethani& supported by many members, that Rs 1 Lakh from the society should be given to the organizers of next Annual conference of Society, three members sub-committee comprising of Dr Surjit Ghatak (Jodhpur) as chairman and Dr. Avinash Abhaya (Chandigarh) & Dr C S Ramesh Babu (Muzaffar nagar) as members, Committee will also suggest utilization of the more money for variousacademic activities in a proper way.

Recommendations of committee was put before the house for discussion which reads as follows: It is proposed that the Anatomical Society of India shall create a corpus of Fund (suitable name can be selected) for assisting and enhancing various academic activities like conduction of a C.M.E / workshop/Webnars/ Training Programs and any such similar activities in furthering the enhancement and updating the knowledge of Anatomical sciences.

- 1. CME/Workshop Assistance Fund: To support the development of excellent educational initiatives, an assistance fund of maximum up to Rs. 1 Lakh be provided to the Organizing Secretary of the National Conference of A.S.I. for conducting C.M.E. / Hands-on Workshop. The fund can be utilized for payment of Honorarium (including travel expenses, if any) to the Guest speakers, purchase of mementos, printing of Certificates etc. The Organizing secretary shall send a request letter to the General secretary in this regard specifying the topic of CME, Names of the Guest Speakers and other details and submit the proposal of expenditure which shall be forwarded to the Treasurer for payment of Assistance Fund. The above said assistance fund can be released in advance to the Organizing secretary and it is the responsibility of the Organizing secretary to finally send the required expenditure bills to the Secretary / Treasurer. (ICMR also releases fund in advance for specific purposes and the bills are sent later after completion of the CME. A similar procedure, application form can be adopted).
- 2. To encourage Postgraduate students of Anatomy <u>and Senior Residents</u> Short Term Training Grant/Fellowship Training Fund can be constituted and be granted to selected candidates, based on merit, to undergo Short-term Training (02 to 06 weeks) in specialized areas like Cytogenetics, Prenatal Ultrasound, stem cell research, specialized microscopy techniques like electron microscopy, confocal microscopy or any such suitable fields of research in Institute of National Importance or reputed national centres like CSIR, CCMB etc. Such assistance of up to Rs. 20, 000 for each candidate may be granted. Every year assistance can be granted to 05. Selected candidates. The selected candidates should be an ordinary member of ASI at the time of application with subsequent approval to become a Life Member and has paid the membership fee for becoming a life member

- 3. The new CBME curriculum mandates the MBBS students to undertake "Electives" in Pre- and Para-clinical subjects as a short-term research project. To promote electives in Anatomy, a *Research Assistance Fund* of Rs. 10,000/- be granted to the MBBS students to take projects in Anatomy. Such grants can be awarded to 10 students every year. The proposal of elective can be forwarded through Head of the Department to Secretary, ASI and after scrutiny by a committee constituted for this purpose, grants can be released to selected MBBS students. (ICMR grants such assistance to MBBS students).
- 4. Travel Grant. To inculcate interest in research activities, students undergoing Postgraduation in an academic or research institution in India, who are willing to present the results of their research in CLINICAL ANATOMY related topics as Oral / Poster presentation can be granted funds to attend the National Conference of Anatomy. This assistance is granted to meet out registration fee of the conference, if any, and travel expenses. Every year 10 students can be given such grant, maximum up to Rs.10,000/-. The applicant should have his/her paper accepted for presentation in the event. Only those Postgraduates who have not received travel support in the previous years from any funding agency are eligible for consideration.
- 5. Book Grant: To give financial assistance to meritorious students for purchase of books required for their studies in MBBS courses in any recognized medical institution in India Economically poor students pursuing medicine who score Honors / Distinction in Anatomy in First Professional MBBS examination can be granted book allowance of up to Rs. 15,000/-. Such book allowance can be granted to 10 students every year.
- 6. Travel Reimbursement: Rs 5000/- each / As actual to each elected / nominated executive body member attending the meeting. This reimbursement shall be given to those executive committee members (including Returning Officer, Joint Secretary, Joint Editor, Joint Treasurer) who attend the EC meeting and who did not receive any such grant from their parent institutions/ Government / any such agency. The EC member shall give an undertaking to the effect that they did not receive any such reimbursement from their parent institution / government to claim the reimbursement from ASI.
- 7. Increase in number to awards & their cash amount: Award session papers, Oral presentation per category, Poster each session. Cash prize for existing Awards (Oral & Poster) can be doubled and suitable amendments be made in the Rules and Regulations.

<u>BEST PAPER CASH AWARD</u>: A cash award of 4000/- to each selected candidate presenting an Oral presentation judged as Best Paper in each subcategory (eg. Clinical Anatomy, Gross Anatomy, Histology, Radiological Anatomy etc) [the subcategory as declared by the Organizing Secretary or determined by the EC & GB of ASI]. Similarly, a cash award of Rs. 3000/ each for Best Poster in each subcategory. The Organizing Secretary shall make suitable arrangements for categorizing the Oral Presentations / Posters for a proper judgement.

Members discussed the recommendations of EC point wise and G B approved the decisions taken as follows -Point number 1 approved with an enhancement of **assistance to 1.5 Laks instead of 1 lakh**. This fund will be released by treasurer only a month before the conference and organizing secretory of conference is required to submit audited expenditure and income statement. Further Dr G.P. Pal vice president suggested and seconded by Dr S L Jethani and approved by all to provide financial assistance up to the tune of Rs 1 Laks per year to the institution for organization of hand on work shop under the **Aegis of ASI**. Work shop shall be attended by minimum 25 life members.

-Point 2 point 3 point 4 and point 5 was not approved.

- **Point 6 approved** with enhancing the limit of reimbursement to10,000/- and recommended giving such grant to all office bearers and EC members with strict compliance of undertaking to the effect that they did not receive any assistance from parent institution/ government/ any other agency.

- Point 7 not approved.
- Committee further deliberated on the issue and recommended **double the cash amount of all the awards and orations.**
- C- Mint. GB-19 4 (iv) A three members sub-committee comprising of Dr. P K Verma (Hyderabad), Col. B K Mishra (Retd.) (Pune) and Dr. Madhusmita Panda (Cuttack) was constituted to elaborate the facilities required for the Organization of Annual Conference (NATCON) of the Society. The subcommittee shall submit its report at earliest to the Gen. Secretary Not received any communication. EC authorized secretory to form a new committee.
